	separate check, which is returned to the homeowner after a successful
	post-event inspection showing that the clubhouse and facilities are left in
	original condition. The Security Deposit will be used by the Association to
	clean or make repairs if the facilities are not left in original condition.
Rental Agreement	The homeowner must sign a Rental Agreement and pay the rental fee and
	security deposit before the clubhouse is reserved.
Available Hours	Friday and Saturdays: 8:00 AM until 11:00 PM
	Sunday through Thursday: 8:00 AM until 10:00 PM
Security Cameras	All who use the clubhouse are notified that video cameras may be in use in
	and around the premises.
Prohibited Activities	No smoking in the clubhouse.
	 Tape and/or Thumbtacks may NOT be used on the walls.
	No unreasonably loud noise.
	All state and local regulations and laws must be followed.
	See the Rental Agreement for other information.
Right to Refuse to	The Association reserves the right to refuse to rent the clubhouse to any

	violated state and/or local laws or regulations while on the property, or
	caused damage to the property.
